# PROCEDURES FOR ADMISSION TO THE WESTERN DISTRICT BAR

<u>Eligibility</u>: Any member of the Bar of the Supreme Court of the United States, or of any United States Court of Appeals, or of any District Court of the United States, or a member in good standing of the Bar of the highest court of any state of the United States, is eligible for admission to the Bar of this Court.

<u>Procedure for Admission</u>: Complete pages one, two, and three of the application. Do not complete page four. You will complete page four when you are administered the oath of admission. Return all four pages to:

You have six months to complete the admission process. If you do not take the Oath of Admission within this time, a new application must be submitted. There are two ways to seek admission:

#### 1. Admission Based on Committee Approval:

The application will be referred to the Court's Committee on Admissions and Grievances for investigation into the applicant's qualifications and fitness to be admitted to the Bar of this Court.

The Clerk's Office will notify the applicant regarding scheduling an interview with a member of the Committee. Applicants living in the Oklahoma City area (including Norman, Moore, Edmond, etc.) are required to schedule a personal interview. However, if an applicant lives outside the Oklahoma City area, the applicant may be excused from an interview by submitting with their application **three notarized affidavits** from a member of the Bar of this Court vouching for the applicant's character and qualifications. Upon a favorable report of the Committee, the applicant may be admitted.

In the fall and spring each year, a ceremony will be scheduled by this Court. Unless excused by the Court, all applicants seeking admission based on Committee approval must attend.

#### 2. <u>Admission Based on Certificate of Good Standing:</u>

Any attorney who is a member in good standing of any other Federal court and has practiced at least one year may be admitted by reciprocity, provided the attorney submits a written petition for admission, attaches a certificate of good standing issued within the past six months, pays the admissions fee, and complies with subsection LCvR83.2(a) of the Local Rules of this Court. Such applications shall be forwarded to the Committee for review. If after two weeks no member of the committee raises objection, the application will be processed by the Court. Applicants admitted on a certificate of good standing without objection by the Committee are not required to attend the admission ceremony but are encouraged to do so. Such applicants may be sworn in individually by making arrangements with the Attorney Admissions Deputy in the clerk's office.

<u>Fees</u>: There is a one-time admission fee of \$200.00. Please make checks payable to the United States District Court Clerk. The Court Clerk accepts the following credit cards: Discover, MasterCard, Visa, American Express, and Diners Club.
