

## Lost Password Instructions

The Lost Password feature will only work if the email address on file for you is correct. If the primary email address for your account is incorrect, you will need to call the ECF helpdesk at 405-609-5555 or 888-609-6593.

1. Open the CM/ECF login page. <https://ecf.okwd.uscourts.gov/cgi-bin/login.pl>
2. Select “click here.”
